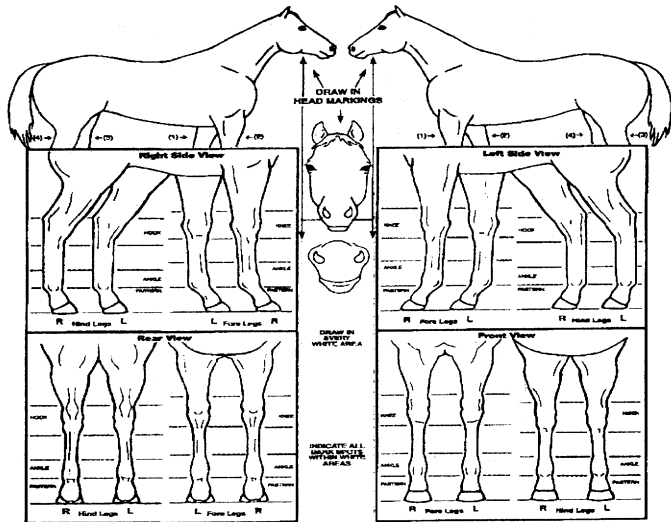

## **HEALTH CERTIFICATE, BRAND INSPECTION & COGGINS TEST IDENTIFICATION AND OWNER**

To accomplish all of the above and have them filed for pre-registration (thereby permitting rapid movement through the Check-in and Registration at the National High School Finals Rodeo in Rock Springs, Wyoming), you must have the following:

- 1) Health Certificate and Coggins Test can be the SAME document. Have the veterinarian issuing your Health Certificate read the following:

### **HEALTH REGULATIONS:**

Health Certificates must be presented along with other records during Stall Check-In and will be returned to you. **Consignee of Health Certificate must be National High School Finals Rodeo Committee, Rock Springs, Wyoming.** All horses must be accompanied by a proper and current Health Certificate issued by a licensed veterinarian within 30 days of the opening date of the rodeo. The Health Certificate must certify that said animals are free from contagious disease and state the number, description, sex and ages of the horse(s).

All horses must show proof that each animal has had a negative Coggins Test conducted within 12 months of the opening date of the NHSFR. The date of the test and the name and address of the laboratory conducting the Coggins Test shall be recorded on the Health Certificate. If you are from a state that requires re-entry papers, PLEASE CHECK WITH YOUR LOCAL AUTHORITIES AND VETERINARIANS TO SEE WHAT PAPERS YOU WILL NEED FOR RE-ENTRY. YOU ARE RESPONSIBLE FOR YOUR OWN RE-ENTRY PAPERS AND REQUIREMENTS.

- 2) Identification of animal and owner's Identification Chart Information should correlate.
  - A. Identification Chart: (Including owner and contestant's name)
    1. Draw markings on chart on reverse side of this form.
    2. State name, sex, breed, tattoo, brands color etc.
  - B. Keep both copies of horse ID forms to bring with you to check-in.
- 3) Make three copies of the following documents: Health Certificate, Coggins Test, Identification Chart and Brand Inspection if from brand area. **DO NOT GIVE ANY OF THESE DOCUMENTS TO YOUR STATE SECRETARY.**
  - A. Original documents to accompany your horse at all times in the truck or trailer while in route. These will be turned in at Horse Check-in when the horse enters the Sweetwater Events Complex: Health Certificate, Coggins Test, ID Chart. **HORSE WILL NOT BE ALLOWED ON THE GROUNDS WITHOUT THESE DOCUMENTS ACCOMPANYING THE HORSE. ORIGINAL FORMS MUST BE PRESENTED AT CHECK IN AS WYOMING LAW DOES NOT ALLOW FOR COPIES TO BE PRESENTED.**
  - B. One set of copied documents should be kept in a safe place with you (personal luggage) to make additional copies if needed.
  - C. Enough copies of the documents should be made to turn in at check points, weigh stations, etc. as needed en route to comply with interstate health certificate requirements.

### **QUARANTINE:**

All horses will be inspected upon arrival at the rodeo grounds; any abnormal findings on a horse will result in quarantine until release by the veterinarian in charge.

### **BRAND INSPECTION:**

A brand inspection is required per Wyoming law. Fees per Wyoming statute: **\$12.00 per head.**

### **VACCINATIONS:**

It is prudent that horses are updated on their annual vaccinations, including a West Nile Virus vaccine.

- 4) **CHECK IN INSPECTION:**

When arriving to the Sweetwater Events Complex in Rock Springs, Wyoming, you will be subject to all Inspection Laws of the State of Wyoming, including brand inspection whether from brand area or not which will **include a fee of \$12.00 per head.** Upon your arrival, all original inspection papers and original proof of ownership papers will be returned to you.

At the conclusion of the rodeo, **you will not need to check-out.**

**ALL HORSES ON THE GROUNDS MUST HAVE A BRAND INSPECTION PER WYOMING LAW.**
