2018 NATIONAL HIGH SCHOOL FINALS RODEO STALLING INFORMATION

Rock Springs, Wyoming

Stall Policies:

Each contestant entering the timed events or the queen contest will be allowed only one stall per event. Steer wrestlers and cutters will be allowed two stalls each. **ABSOLUTELY NO STALLS** will be allowed for tack.

Before you leave home:

- Get current Coggins, Health Papers, Brand Inspections (where required) on each horse. You **MUST** have current paperwork to check-in. <u>Health Inspection is also required for Goats.</u>
- Complete Horse ID forms for each horse. Reference contestant's name on ALL paperwork.
- Check with your local veterinarian on travel and quarantine status for infectious diseases such as West Nile Virus before you leave home.
- Leased horses must have the same current paperwork and it is up to the contestant to inform the horse owner of the requirements. Horse owners must bring paperwork with the horse to check-in. Reference contestant's name and qualifying state on all paperwork.

Check-in Procedures in Rock Springs:

- Check-in will begin at 12:00 p.m. (noon) on Thursday, July 12th and will operate 24 hours a day until 7:00 a.m. Sunday, July 15th. No early check-ins will be allowed.
- All horses MUST be checked in by 6:00 pm Sunday, July 15th.
- All horses entering the Complex grounds must go through check-in at the Grandstands Entrance
 - o <u>Exception:</u> On Sunday, between 7AM and 6PM, check in with the Caretaker, through the Livestock Entrance, past the campground. Call 307-352-6789 ext. 100 for more information.
- Only Studs are placed in stud stalls. Studs will be in the permanent stalls, east of the Indoor Arena.
- During the check-in procedure, contestants will need to unload their horses, take their paperwork and lead their horses to the check-in area and then on to their assigned stall. One person will need to drive the vehicle to the parking area and wait for the contestant to get there.
- Horses are only allowed in the stall and arena areas. Absolutely **NO HORSES OR GOATS** are permitted in the RV Parks or on the Complex grounds outside of the arena and stalling areas.
- Brand Inspections are required by Wyoming State Law. Inspectors will be on the grounds during daylight hours throughout check-in and during the rodeo. **Inspections cost \$12.00 a horse.**
- Do not wash horses or tack in the barn. Please use the wash racks.
- Do not tie horses up to any water faucets inside or outside.
- Please keep stall area cleaned out and haul manure to designated dump areas.

Check-Out Procedures:

Horses will not need to check-out before leaving the Sweetwater Events Complex grounds.

Damages/Alterations:

ANY alterations to a rented stall will be charged a \$100 damage fee by NHSRA after NHSFR move-out.

Hold Harmless Statement
