# STALLING & HORSES/GOATS CHECK-IN

## Stall Policies:

Each contestant entering the timed events or the queen contest will be allowed only one stall per event. Steer wrestlers and cutters will be allowed two stalls each. **ABSOLUTELY NO STALLS** will be allowed for tack.

## Before you leave home:

- See back of Horse Identification Paper for Nebraska health paperwork needed to check-in each horse AND goat that will be on grounds. Paperwork must be signed by a veterinarian before leave on your trip and completely filled out before you enter the grounds with your horses & goats. Reference contestant's name and state/province/country team on **ALL** paperwork.
- Leased horses must have the same current paperwork and it is up to the contestant to inform the horse owner of the requirements. Horse owners must bring paperwork with the horse during Horse Check-in same days/deadline. Reference contestant's name and qualifying state on all paperwork.
- Check with your local veterinarian on travel and quarantine status for infectious diseases such as West Nile Virus, Scrapies etc. before you leave home.
- Brand inspections are NOT required by Nebraska State Law, but may be by other states while traveling.

## Check-in Procedures in Lincoln:

- **Contestant Check-in will begin at 12pm (noon) on Thursday, July 15th and will operate 24 hours a day until 7am Sunday, July 18th.** No early or late contestant check-in allowed without prior NHSRA main office staff written approval.
- **Horse & Goat Check-in** also starts at 12pm (noon) on Thursday, July 15<sup>th</sup> and continues after Contestant Check-in closes until 6 pm Sunday July 18<sup>th</sup>. **All horses & goats, including leased horses, MUST be checked in by 6pm Sunday, July 18th.**
- All horses and goats entering the Lancaster Event Center Fairgrounds must go through Stall Check-in starting at Gate 2 on Havelock Avenue (gate closest to 84th Street on south side of Havelock).
- Only Studs are placed in stud stalls. Studs will be in the Pavilion 2 building.
- During the check-in procedure, contestants will need to unload their horses, take their paperwork and lead their horses to the check-in area and then on to their assigned stall.
- There will be trailer clean-out available right in the same parking lot where the horses are removed.
- After trailer clean-out, another person besides the contestant going through horse check-in will need to drive the vehicle with the trailer to the empty Horse Trailer Parking Lot I on NW corner of grounds or take living quarters trailers to the assigned campground, and wait for the contestant to get there, if possible to allow trailer space for others checking in. You will get

grounds maps upon check-in and you'll find the grounds are very walkable and we will have lots of folks to give directions. At this same point, rental golf carts may be picked up at north end of same trailer check-in parking lot by 3rd person in your party if you prefer.

### **Horse (& Goats) Rules & Services on Grounds:**

- Horses are only allowed in the stall and arena areas and there will be a designated path between the stalling area and the main outdoor performance arenas and the trailer parking/load out lot on NW corner of grounds.
- Absolutely **NO HORSES** are permitted in the campgrounds, in parking lots/driveways, on the adjacent hiking/biking trail or anywhere outside of the arena and stalling areas.
- Warmup spaces and times will be posted upon your arrival.
- Do not wash horses or tack in Pavilion 2 indoor stalls or in the outdoor stalls. Please use the wash racks.
- Do not tie horses up to any water faucets, fences, signs, buildings (other than wash rack areas) or trees--inside or outside.
- Please keep your stall area cleaned out and haul manure to designated dump areas.
- Water will be available to haul with your own bucket from nearby water faucets.
- Shavings, alfalfa and brome hay, Purina feed and a variety of equine supplies will be available on grounds.
- Goats are allowed only in the Stalling area and the Campground as long as others are not bothered and no traffic/driveways blocked. Goats may NOT be in the Trailer Lot I at any time.

### **Check-Out Procedures:**

- Horses will not need to check-out before leaving the Lancaster Event Center Fairgrounds.
- Bring your trailer if not already there to Lot I. Trailers always enter Gate 2 off Havelock and exit Gate 1 on 84th Street.
- Walk/lead your horse from the stalling area over to the Trailer/Load Out Parking Lot I on the NW side of the grounds.
- **\*Damages/Alterations: ANY** alterations to a rented stall will be charged to you as a minimum \$100 damage fee by NHSRA after NHSFR move-out.

### **Hold Harmless Statement**

This agreement is made upon the express condition that the National High School Rodeo Association, Lancaster County Agricultural Society, Inc. d/b/a Lancaster Event Center Fairgrounds, NHSFR Lincoln, Lancaster County, City of Lincoln, its agents and employees shall be free from all liabilities and claims for damages and/or suits for or by reason of any injury, or death to any person or property of the Lessee, its agents or third parties, from any cause or causes whatsoever while in or upon said premises or any part thereof during the term of this agreement or occasioned by any occupancy or use of said premises or any activity carried on by the Lessee in connection herewith, and the Lessee hereby covenants and agrees to indemnify, defend, save and hold harmless the National High School Rodeo Association, Lancaster County Agricultural Society, Inc. d/b/a Lancaster Event Center Fairgrounds, NHSFR Lincoln, Lancaster County, City of Lincoln, its agents and employees from all liabilities, charges, expenses and costs on account of or by reason of any such injuries, deaths; liabilities, claims, suits or losses however occurring or damages growing out of the same. See signs on grounds about Nebraska Equine Liability laws.
