



2023 PERSONAL GOLF CART USAGE AT NATIONAL FINALS

LAST YEAR, THE NHSRA PARTNERED WITH OUR LONG-TERM FRIENDS FROM GTI AND DEVER TO DEVELOP A SUITABLE SOLUTION FOR PROVIDING GOLF CARTS FOR OUR NATIONAL FINALS CONTESTANTS. THIS YEAR, WE HAVE AGREED TO TAKING RESERVATIONS FOR UP TO 100 PERSONAL GOLF CARTS AT THE FINALS IF THE FOLLOWING RULES ARE ADHERED TO AS STATED BELOW:

1. UP TO 100 PERSONAL GOLF CART RESERVATIONS CAN BE MADE THROUGH OUR GOLF CART VENDOR.
2. PERSONAL GOLF CARTS **MUST** BE REGISTERED WITH DEVER/HERC RENTALS, OR WE WILL PARK ANY GOLF CART THAT IS IN VIOLATION FOR THE REMAINDER OF THE FINALS. IF A PERSONAL GOLF CART OPERATOR IS IN VIOLATION OF ANY RULE THAT HAS BEEN ESTABLISHED THE CONTESTANT'S BACK NUMBER MAY BE PULLED AND DISCIPLINARY ACTION COULD/WILL FOLLOW.
3. WHEN REGISTERING YOUR PERSONAL GOLF CART, YOU WILL BE CHARGED A \$200 PERMIT FEE. PERMITS ARE OBTAINED IN THE SAME WAY YOU RENT A GOLF CART (BY CALLING OUR VENDOR). INFORMATION THAT WILL BE COLLECTED FOR THIS PROCESS IS LISTED BELOW.
4. ALL PERSONAL GOLF CARTS MUST ADHERE TO THE SAME RULES AS RENTALS. **ONLY GOLF CARTS WILL BE ALLOWED. NO ATV/SIDE BY SIDES/UTV/GO CARTS/ETC.**
5. NO GOLF CARTS ARE ALLOWED OFF GROUNDS. (PERSONAL OR RENTAL)
6. ALL PERSONAL GOLF CARTS MUST BE EQUIPPED WITH HEADLIGHTS AND TAILLIGHTS.
7. THE FOLLOWING INFORMATION IS REQUIRED WHEN A PERSONAL GOLF CART IS REGISTERED THROUGH HERC RENTALS/DEVER:
 - ✓ SIGNED COPY OF THE NHSRA FORM
 - ✓ PROOF OF OWNERSHIP OF YOUR GOLF CART
 - ✓ PICTURE OF GOLF CART
 - ✓ MINIMUM \$100,000 CERTIFICATE OF LIABILITY INSURANCE FROM YOUR INSURANCE CARRIER NAMING NHSRA, HERC RENTALS/DEVER, (GEORGIA NATIONAL FAIRGROUND OR CAMPLEX).
 - ✓ SIGNED HERC RENTALS/DEVER FORMS THAT INCLUDE RULES AND CREDIT CARD INFORMATION.

ONCE THE PERSONAL GOLF CART IS AT THE VENUE- (PERSONAL GOLF CARTS THAT HAVE BEEN REGISTERED THROUGH HERC RENTALS/DEVER) WILL NEED TO BE DELIVERED TO THE GOLF CART VENDOR TO OBTAIN A STICKER THAT MUST BE PLACED ON THE COWL OF THE GOLF CART. ALL REGISTERED PERSONAL CARTS MUST HAVE THIS STICKER TO SHOW THEY HAVE BEEN APPROVED/REGISTERED OR RISK LOSING THE PRIVILEGE OF USING THEIR GOLF CART FOR THE DURATION OF THE EVENT.

NHSRA IS TAKING A HARD LINE ON DISCIPLINING INFRACTIONS. NHSRA PERSONNEL OR LEADERS. SECURITY PERSONNEL AND FAIRGROUND MANAGEMENT HAVE THE AUTHORITY TO CONFISCATE A GOLF CART AND/OR PULL A CONTESTANT'S BACK NUMBER IF THEY DO NOT FOLLOW THE RULES.

DISCIPLINE MAY INCLUDE THE DISQUALIFICATION OF A CONTESTANT.

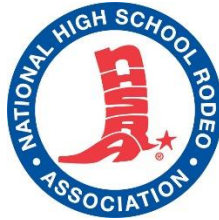
I HAVE READ AND AGREE TO THE GNFA / CAM-PLEX RULES _____(INITIAL)

1. ONLY SELECT PERSONAL GOLF CARS WILL BE ALLOWED AND SUBJECT TO SECURITY AND RULES ENFORCEMENT. **MUST BE PRE-REGISTERED AND APPROVED BEFORE EVENT.** [REDACTED]
2. All golf cars must be registered, credentialed, and permitted. The permit must be prominently displayed on the front driver's side hood of the golf car. [REDACTED]
3. All drivers must be **licensed driver 16 years of age or older to operate a golf car** or the golf car will be confiscated and only released to an adult. [REDACTED]
4. Drivers must show proof of age and license if stopped by security or show their authorized wristband. [REDACTED]
5. There is a **1:30 am curfew** on golf car usage for anyone 21 years and under at the **High School Finals Rodeo**. There is no restriction on golf car usage by parents or adult guardians. [REDACTED]
6. There are several off-limits areas on the event grounds. Restricted areas will be signed and flagged as such and golf cars are prohibited. Golf Cars are not permitted off grounds or on public roads. Golf Car are not allowed inside the horse/barns/tents at any time. Golf Cars in Prohibited areas will be confiscated immediately and reported to officials. [REDACTED]
7. When not in use, it is up to the owner of the golf car to secure it. Herc Rentals/CAM-PLEX/NHSRA is not responsible for lost/stolen golf cars. [REDACTED]
8. **The speed limit on grounds must be adhered to. Golf cars that are being operated at unsafe speeds will be confiscated and parked for the remainder of the event.** [REDACTED]
9. Do not exceed the capacity allowed on the golf car. Each person on the car must be **seated** on the bench seat (2-passenger golf car/2 people only, 4-passenger golf car/4 people only, 6-passenger golf car/6-people only, utility truck golf car/2 people only absolutely no person allowed in the truck bed). [REDACTED]
10. Absolutely no drinking alcohol or use of drugs and driving on the golf car or event property is allowed at any time. No texting and driving as well. [REDACTED]
11. Reckless driving, abuse of the rules, and irresponsible driving will result in loss of golf car. Absolutely no water balloon fights on golf cars. **(NO Tolerance Policy 1st offense golf car can/will be confiscated for remainder of event with no refund).** [REDACTED]
12. Golf Car must be driven in a safe manner and all rules followed to maintain your golf car privilege. [REDACTED]
13. Operating a golf car as well as being a passenger on a golf car can pose a risk of injury or death, operator must adhere to all safety rules to insure the safety of everyone attending the event. [REDACTED]
14. Security will be onsite arranged by Herc Rentals and NHSRA – they will have full authority to confiscate golf cars, write tickets and/or warnings and to stop any golf car on grounds for rules infractions and/or unsafe driving. Periodic governor checks will be performed throughout the day on any/all golf cars. [REDACTED]

It is expressly understood and agreed that Herc Rentals, CAM-PLEX Events Center, the NHSRA, their staff, owners or operators and agents shall not be held liable for damages or injuries of any kind, whether to persons and/or property, and/or loss of time, and any other loss arising from the use, operation of, or in any way connected with the personal golf car being allowed on grounds. I have read, understand that this is a legally binding agreement and accept all the terms of this agreement. Failure to comply with these terms may result in the termination of your event credentials, the golf car being impounded and forfeiture of golf car privileges for the remainder of the event WITH NO REFUNDS GIVEN.
