I acknowledged that those inherent risks include dangers or conditions which are an integral part of equine or livestock activities, and may include the following:

The propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them;

The unpredictability of the animal's reaction to outside stimulation such as sounds, sudden movement, and unfamiliar objects; or collisions with other animals or objects; or the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability.
